TERMS AND CONDITIONS:

GRANT OF REVOCABLE OCCUPANCY: Pursuant to Chapter 244 of the Nevada Revised Statutes and Chapter 12.02 of the Pershing County Code, Pershing County hereby grants a revocable permit to _____ hereinafter referred to as "Permittee", to make and (excavation) (encroachment) (street cut) partially or entirely within the right-of-way as shown as shown on the drawings attached hereto as Exhibit "B", and made a part hereof.

The project permitted hereby is for the benefit of the permittee and/or his real property and all restrictions and conditions set forth herein shall be binding upon the permittee, his legal representatives, successors and assigns. Said permit is more particularly described as follows:

- 1. PERMIT APPROVAL:** *This permit is issued contingent upon the Pershing County Road Superintendent's (hereinafter referred to as "Superintendent"), approval, prior to the beginning of the project, of the construction schedule, safety and traffic control measures and any other facet of the permitted project which he deems prudent to control in the interest of the County and the traveling public. Failure to secure such approval from the Superintendent shall render this permit null and void.*
- 2. NOTIFICATION PRIOR TO START OF WORK:** *Permittee shall notify the Pershing County Road Department daily of all work activities, (775) 273-7554. Please leave message with permit number, date and time of work. Notification shall be given before 8:00 a.m. for work performed that same day.*
- 2. CALL BEFORE YOU DIG:** *Permittee shall verify the location of, and protect all nearby utilities and underground infrastructure. The Permittee shall be responsible for repair of damaged utilities or other infrastructure. CALL BEFORE YOU DIG 1-800-227 -2600, 48 HOUR NOTICE REQUIRED.*
- 3. WORK NEAR TRAFFIC SIGNALS:** *Permittee shall contact the Pershing County Road Department a minimum of two working days prior to any construction near a traffic control system, i.e. signals, flashing warning devices, information boards, and street lamps, (775) 273-7334. Underground locates will be performed Monday through Friday, 7:00 a.m. to 3:30 p.m.*
- 4. EXPIRATION OF PERMIT:** *This permit is valid for 90 days from the date of approval. If the expiration date falls on a weekend or county observed holiday, the date of expiration will be at 5: 00 p.m. on the next business day. In order to continue work on an expired permit, a new permit must be obtained.*
- 5. COPY OF PERMIT AT WORK LOCATION:** *A copy of the permit and approved plans shall be retained at the construction site at all times.*

6. **WORK SPECIFICATIONS:** All work shall be performed in accordance with the Pershing County Design Criteria and Improvement Standards, The Washoe County Standard Specifications for Public Works

Construction (Orange Book), and the Uniform Building Code section on Excavating and Grading, 1997 Edition.

7. **COMPLIANCE WITH MUTCD:** The Permittee shall fully comply with the provisions of the Manual of Uniform Traffic Control Devices (MUTCD). The Road Superintendent shall approve variances from the MUTCD and discretionary portions thereof. All Flaggers shall have valid certification from the State of Nevada.

8. **ROAD CLOSURES:** This permit does not allow for the closure of any road. Traffic shall be permitted to pass through work zones at all times. In the event a road must be closed, Permittee shall contact the Pershing County Road Department for a Road Closure Application (775) 273-7334.

9. **LOCATION FOR PLACEMENT OF UTILITIES:** New or relocated utilities shall not be placed closer than 6 feet from existing edge of pavement, or 6 feet from roadway edge on gravel and dirt roads. New or relocated utilities shall also not be placed within the roadside ditch area. All utilities, depth included, shall be installed in accordance with Pershing County Design Criteria and Standards. Minimum cover is required in all circumstances, including utility crossings of roadside ditches.

10. **PRIVATE DRIVEWAY CROSSINGS:** The Permittee shall coordinate driveway crossings and repairs with the property owner. No driveway crossing shall be made without 48-hour advance notice to the affected property owners, residents, or tenants. Access to private properties shall be maintained at all times.

11. **ROADWAY CROSSINGS:** All utility crossings shall be jacked or bored under the roadway. In the event a jack or bore cannot be completed due to rocky soil or other unforeseen conditions, the County Road Supervisor may approve the road to be cut using a Rock Saw. County approval must be given before any road cut is performed.

12. **ROADWAY REPAIRS:** In the event a road cut is approved, all repairs shall be performed in accordance with the Pershing County Design Criteria and Improvement Standards. Road cuts shall be temporarily repaired with cold-mix asphalt by the end of the same workday. Permanent repairs using hot-mix asphalt shall be completed within 10 working days. Roadways constructed of recycled asphalt material shall be repaired within 10 working days with hot - mix asphalt.

13. **COMPACTION REQUIREMENTS:** Permittee shall obtain minimum 90% relative Compaction on all Roadside Shoulders, and 95% Relative Compaction on all Roadway Sections. Applicant shall provide compaction tests in accordance with the Washoe County Standard Specifications for Public Works Construction (Orange Book).

14. **EXCAVATION WITHIN RIGHT-OF-WAY:** All trenches and other excavations shall be closed or steel plated by end of same workday.

15. **REMOVAL OF SPOILS:** All spoils shall be removed from work area within 10 working days.

16. **DAMAGE TO PROPERTY:** The Permittee shall repair at their expense, and to the property owner's satisfaction, all damage to improvements on public or private property. This includes but is not limited to the repair or replacement of asphalt surfaces, driveway culverts, street striping, and markings, traffic signs, guide markers, landscaping, and irrigation systems.

17. **INSPECTION:** The Permittee shall call the County Road Superintendent for a final Inspection prior to the expiration of the permit or upon completion of the work (775) 273-7334. The Superintendent shall be given a minimum of two days advance notice. The Superintendent will submit a list of deficiencies to the Permittee for correction if correction is required.

18. **NOTICE OF COMPLETION:** After correction of all deficiencies, and after acceptance of the improvements, the County will issue a notice of completion on the project.

19. **WARRANTY:** The Permittee shall warrant the work for one year from the date of notice of completion. The Permittee shall repair at his own expense all failures that occur during this period. Failure to request a final inspection and failure to obtain a notice of completion may delay issuance of new permits.

20. **INDEMNIFICATION:** The Permittee, its successors and assigns, shall indemnify the County of Pershing and hold it harmless from and against any and all liability for injury to persons or damage to the properties whether said properties may belong to Permittee, County or to third parties, which injury or damage is sustained by reason of any cause directly resulting from the exercise of the privilege herein granted. Permittee further agrees to indemnify the County of Pershing and hold it harmless from and against any and all liability for damages to the facilities which may result from road maintenance operations.

21. **REMOVAL:** Upon notification from the County of Pershing of the necessity therefor, the Permittee shall adjust or remove the facilities at its own expense, within thirty (30) days after receipt of such notice, unless the emergency of the situation requires the work to be done in a shorter time.

22. **SPECIAL TERMS AND CONDITIONS:**

THE PERMITTEE AGREES TO THE ABOVE RESTRICTIONS AND CONDITIONS AND ACKNOWLEDGES THAT SAID RESTRICTIONS AND CONDITIONS SHALL RUN WITH THE PERMITTEE'S REAL PROPERTY BENEFITTED BY THIS PERMIT AND BE BINDING UPON PERMITTEE, HIS LEGAL REPRESENTATIVES, SUCCESSORS, HEIRS AND ASSIGNS.
